

Wreath Contest Rules

Tulare Downtown Association, Inc.

The following rules will govern the operation of the wreath contest. (Sept. 2019)

- 1) Contest is open to everyone as an individual or group. If a group, any prize money awarded is presented to the group as a whole.
- 2) Judging by an independent panel of judges, with each entitled to one (1) vote.
- 3) Wreaths must be decorated by the entrant. No more than one (1) wreath per individual or group will be eligible for judging.
- 4) No names can be visible on the wreaths.
- 5) Wreaths MUST be rigid and circular in shape with an opening in the center. All wreaths must be a minimum of 24" in diameter with a maximum diameter of 48 inches. All ornamentation must be weather-proof. Maximum acceptable weight for wreaths is 30 pounds. All wreaths must be hangable.
- 7) Wreaths may not contain any food products or perishable items. Wreaths requiring an electrical hook up will not be accepted.
- 9) Wreaths must be delivered to 306 E. King Ave, the offices of the Tulare Downtown Foundation/Association by 5 PM on November 1, 2019. Wreaths brought in after the deadline will be displayed. However, installation and judging will not be delayed accommodating these wreaths.
- 10) Each entry must include a Wreath Contest Entry Form.
- 12) There will be a 1st place cash prize. There will be a second and third place non-cash awards. 1st, 2nd and 3rd place finishers will receive a ribbon.
- 13) TDA board members are used to solve any problems that may arise. The Tulare Downtown Association reserves the right to refuse any entry.
- 11) Winners will be notified by December 9, 2019. Monetary awards may be claimed by contacting the office of the Tulare Downtown Association to make arrangements, or they may be claimed when picking up wreaths on January 10, 2020. Identification and a wreath receipt must be presented to claim awards.
- 12) All entries will be on exhibit in Downtown Tulare from date of installation in November 2019 to their removal January 6, 2020.
- 13) Wreaths must be claimed on January 10, 2020 from 9:00 a.m. to 5:00 p.m. at the offices of the Tulare Downtown Association. Please present your wreath receipt when claiming your entry. If you are unable to claim your wreath on January 10, 2020, from 9:00 a.m. to 5:00 p.m., please call 685-2350 to make other arrangements. All unclaimed wreaths shall become the property of the Tulare Downtown Association.
- 14) All decisions of the judges are final.
- 15) The City and County of Tulare nor the Tulare Downtown Association or Foundation nor Beleza Salon will be responsible for the loss or condition of the entries.
- 16) It is the entrant's responsibility to read and understand the rules of this contest. It is understood by the contestant that images of wreaths may be used in advertising, promotional materials, publications, websites, or any other media in conjunction with the contest with no compensation other than credit of entrant name and title of wreath.
